Admission of students to Christ the King Catholic School is in accordance with the policies established by the School Board of Christ the King Catholic School. (Available upon request). All conditions of this registration must be completed to ensure a place in class for a student.

Tuition Assistance:

A limited amount of tuition assistance is available to parishioners who pay tuition at Christ the King School. Families wishing to apply for tuition assistance must complete the school registration process and a Financial Aid application and submit it to their home parish by April 1, 2010. In the event that your family is granted financial assistance, the total tuition due as outlined on the fee schedule will be adjusted.

FACTS Tuition Management – Monthly Automatic Checking or Savings deductions. Deductions will be made in ten monthly installments beginning in August. Payments can be withdrawn on the 5th or 20th of each month. **ALL NEW FAMILIES CHOOSING THIS OPTION MUST COMPLETE AN ON-LINE FACTS ENROLLMENT FORM AT THE TIME OF REGISTRATION. RE-ENROLLING FAMILIES NEED ONLY TO VERIFY THE ACCURACY OF PAST INFORMATION.** Christ the King School will pay the \$38 administration fee charged by FACTS.
